Mr. Crème presented the Special Exception request for a non-specified use. Mr. Crème presented the use as educational for children and adults. Mr. Crème presented information related to the proposed location of the intended use.

Rebecca and Dale Shoener were sworn in for testimony. Mr. Wood noted there were other individuals at the meeting for the case. Mr. Wood noted there were also school students attending the meeting. Mr. Wood explained the purpose of the meeting was to the students in attendance. Mr. Crème asked Ms. Shoener questions regarding the proposed use, how their current location operates, what is offered as an educational component to the individuals in attendance, the area served by the business, hours of operation and the adult training portion of the business operation.

Mr. Strausser made a motion to approve the request to operate two businesses which provide enrichment programs for children and adults under Section 302. Non-Specified Use. Mr. Trimble seconded the motion. The motion was approved 4-0.

An extension of an additional three (3) years to June 1st, 2028 to complete construction associated with the variances. Mr. Strausser seconded the motion. The motion was approved 4-0.
