

MINUTES FOR MEETING OF THE
MANHEIM TOWNSHIP CIVIL SERVICE COMMISSION

Tuesday, September 10, 2024

I. Call to Order

A Public Session of the Manheim Township Civil Service Commission ("CSC") was held at the Manheim Township Municipal Building on Tuesday, September 10, 2024 at 4:30 P.M. and was presided over by Chairwoman Marsha DiBonaventuro.

Of the seven (7) eligible applicants only six (6) applied. Each envelope was recorded with the date and time received and written on the outside of the envelope along with the application. Sergeant Waltz opened each envelope and provided the names of the applicants as follows: Corporal M. Tropp, Corporal J. Ayres, Corporal C. Lewis, Corporal M. Wiczkowski, Corporal D. Swigart and Corporal K. Carner. Sergeant Waltz verified each applicant as eligible for promotion.

Chairwoman DiBoneventuro asked for any questions or comments from the CSC. Hearing none, a motion was presented by Vice Chairman Singer and seconded by Secretary Broskey to approve the Corporals listed as eligible candidates for promotion. Motion carried unanimously.
