Motion to approve annual appeal mailing costs not to exceed \$250, put forth by Brian Mahon seconded by James Adams, passed unanimously

Motion to approve annual appeal design costs not to exceed \$400, put forth by Brian Mahon seconded by James Adams, passed unanimously

MTPLF account balances reviewed and discussion regarding amounts to transfer for endowment and general fund for library operations. \$50,000 endowment transfer to be put on November agenda.

Motion to approve a \$10,000 transfer from MTPLF Fulton Checking account to the Manheim Township general fund for library operations, put forth by Brian Mahon seconded by James Adams passed unanimously.

Nominating – Joyce Sands and Celso Mesias shared that the Monday BOC meeting on 10/28/24 has an agenda item to appoint the following members to the MTPLF board: Janet Carroll, Beth Crosby and Susan Robertson. James Adams and Joyce Sands to perform orientation for new members and will include a library basement tour of book sale operations, including Amazon sales.

Old Business

Board discussion was held about the Board of Commissioners' ("BOC") recommendation which had been explained by Township Commissioner Stacey Morgan Brubaker and Township Manager Rick Kane at our July 24, 2024, Board meeting, for our MTPL Board to create a MTPLF Board with at least some of that Board's members being different from those of our MTPL Board. The Commissioners seem to see it as being within the authority of our MTPL Board to select and appoint ourselves or others as members of the MTPLF Board. Township Manager, Rick Kane, said at the July 24 meeting that he will provide us with a report on the recommendations of the BOC as explained to us at the July 24th meeting, after which the MTPL Board would consider making appointments to the MTPLF Board. We have not yet received that report from Rick Kane, although the BOC would like this to be addressed in time for the 2025 Township budget.

Discussion regarding a potential Beam Consulting proposal was tabled to re-evaluate mid-2025.

2. **MTPLF has passed a motion to transfer \$10,000 for library operations**
