

MINUTES FOR MEETING OF THE

I. Call to Order

A Public Session of the Manheim Township Civil Service Commission ("CSC") was held at the Manheim Township Municipal Building on Tuesday, March 11, 2025 at 4:30 P.M. and was presided over by Chairwoman Marsha DiBonaventuro.
