Attorney Bernadette Hohenadel described the location of the property and the zoning of the property referencing the submitted site plan.

Ms. Luciani moved to approve the following: a special exception in accordance with Section 301.4.E. to change an existing non-conforming professional office use to a non-conforming medical daycare use; a variance of Section 1106.2.B.5.d. to permit the playground equipment to encroach within the twenty (20) foot perimeter buffer. Mr. Strausser seconded the motion. The motion was approved 5-0.
