## Application Instructions

### Eligibility List – Firefighter/EMT (Full-time and Part-time) for Manheim Township Fire Rescue

Manheim Township will be testing to create an eligibility list for future hiring. A written Civil Service Examination for Firefighter/EMT (full-time and part-time) will be administered to all eligible applicants on Saturday, July 16<sup>th</sup>, 2022, at the Lancaster County Public Safety Training Center, 101 Champ Boulevard, Manheim, PA 17545 at 9:00am.

An orientation session (classroom only) for the Candidate Physical Ability Test (CPAT) will be given immediately prior to the written test on July 16, 2022. The CPAT test will then be administered by the regional consortium beginning in August, with the final test in October for eligible candidates.

The CPAT includes the following: stair climb, hose drag, equipment carries, ladder raise and extension, forcible entry, search, rescue, ceiling breach and pull. A copy of the CPAT Test Preparation Guide will be issued to each eligible applicant during the first orientation session.

All applicants for Firefighter/EMT (full-time & part-time) must complete the Civil Service Examination. Applicants must meet the following requirements:

- U.S. Citizen
- 18 years of age or older
- High school diploma or GED

All applicants for part-time employment must have the following National Board on Fire Service Professional Qualifications (or equivalent) to apply:

- Firefighter I
- Firefighter II
- Pennsylvania Department of Health Emergency Medical Technician or Paramedic (or ability to obtain reciprocity for out-of-state certification)
- Valid CPR/AED
- Pennsylvania Department of Health Basic Vehicle Rescue Technician or NFPA 1006 Core and Vehicle Machinery certifications or equivalent
- Hazardous Materials Operation certification

All applicants for full-time employment must either have all of the above listed fire service-related minimum training (as listed under part-time requirements) and be a graduate of a municipal fire academy, or if the applicant does not possess the above listed requirements, the applicant must be eligible to be registered for a municipal fire academy of the agency's choosing upon hire, which will be at the agency's expense.

Those meeting the requirements listed above, or for full-time who are eligible to be registered for a municipal fire academy, qualify to take the exam. To take this examination, each applicant must complete the attached application and pay the \$50.00 non-refundable application fee. The Civil Service Commission will review all applications prior to the test date. Individuals who are NOT eligible to take the examination will be notified by electronic mail.

Applicants must return the following:

- Application fee (\$50.00 check or money order only – payable to Manheim Township)
- Copy of Driver's license
- Completed application for Firefighter/EMT
- Copy of ALL required prerequisites for the position you are applying for
- Processing form indicating your testing preference for full-time, part-time, or both

If you are a veteran, as defined by current law (attached) and you desire to receive veteran's preference points, attach a copy of your discharge paperwork (DD Form 214) to your application. The DD Form 214 must be the copy that reflects "Reentry Code".

***Applications must be returned or post-marked no later than Friday, July 1, 2022, at 4:00pm. An application fee of \$50.00 made payable to Manheim Township (check or money order only) must accompany the application. Application packets must be marked "Attention Civil Service Commission – Application for Firefighter/EMT". Application packets will only be accepted in-person or via mail/delivery at the Manheim Township Municipal Office, 1840 Municipal Drive, Lancaster, Pennsylvania 17601.***

On the date of the exam, eligible applicants must provide valid government identification (driver's license). Applicants will be notified in writing before progressing to the next step in the selection process. Please refer to the recruitment announcement for the selection process.

Manheim Township is seeking to establish an eligibility list of highly qualified and motivated individuals to fill the role of full-time Firefighter/EMT within the Manheim Township Fire Rescue (MTFR) system. MTFR is an all-hazards agency serving a community of 43,977 residents in 24 square miles from four fire rescue stations. MTFR remains an active combination fire rescue system, currently consisting of two full-time career Chief Fire Officers, one career Fire Marshal, four career Fire Captains, twenty-eight full-time career Firefighters/EMTs, forty-eight part-time career Firefighters/EMTs, one full-time Fleet Mechanic, and over thirty volunteers filling roles including Firefighters, Junior Firefighters, Administrative, and Auxiliary Support. At this time, MTFR is seeking to establish an eligibility list for future full-time Firefighter/EMT positions in FY2023.

The comprehensive selection process will take 3-4 months to complete and will include a written civil service examination, the Candidate Physical Ability Test (CPAT), oral interview, background check to include criminal history and child abuse clearances, a physical examination, drug test, and driver's license check.

Applicants for full-time positions have two (2) options to obtain employment:

**Option #1: In order to be eligible to apply and be invited to the written civil service examination, interested applicants MUST meet the following minimum qualifications at the time of application.**

1. Be a citizen of the United States of good moral character.
2. Be at least 18 years of age at time of hire.
3. Possess a high school diploma or GED equivalency.

4. Possess National Board on Fire Service Professional Qualifications (or equivalent certifying agency) Firefighter I and Firefighter II certification.
5. Possess Pennsylvania Department of Health Emergency Medical Technician (or have the ability to receive Pennsylvania reciprocity for out-of-state certification) and valid CPR/AED certifications.
6. Possess Pennsylvania Department of Health Basic Vehicle Rescue Technician certification, or NFPA 1006 Core and Vehicle Machinery certifications, or equivalent.
7. Possess valid (within previous 12 months) Hazardous Materials Operations level training.
8. Possess a valid Pennsylvania operator's license (Class C).
9. Be a graduate of a Municipal Fire Academy (verifiable academy program conducted by a training academy, educational agency, or full-time municipal fire department).

**Option #2: For those applicants who do not possess previous fire service training/experience, or do not possess all the listed minimum requirements, or who are not graduates of a Municipal Fire Academy, interested applicants MUST meet the following minimum qualifications at the time of the application, and if hired will be registered for a Municipal Fire Academy program of the agency's choosing, at the agency's cost:**

1. Be a citizen of the United States of good moral character.
2. Be at least 18 years of age at time of hire.
3. Possess a high school diploma or GED equivalency.

Candidates will be notified by electronic email to report for the CPAT.
3. CPAT orientation session (classroom only) will be held during the written test on Saturday, July 16, 2022, for all applicants.
4. CPAT orientation, practice sessions, and final test are being scheduled by the regional consortium. Eligible candidates will be notified by electronic email as to their reporting time for the CPAT orientation, practice sessions, and final test day.
5. Finalist after CPAT testing will be required to complete an oral interview, background check to include criminal history, child abuse clearances, a physical examination, drug test, and driver's license check. Finalist will be notified in writing of dates for this process.

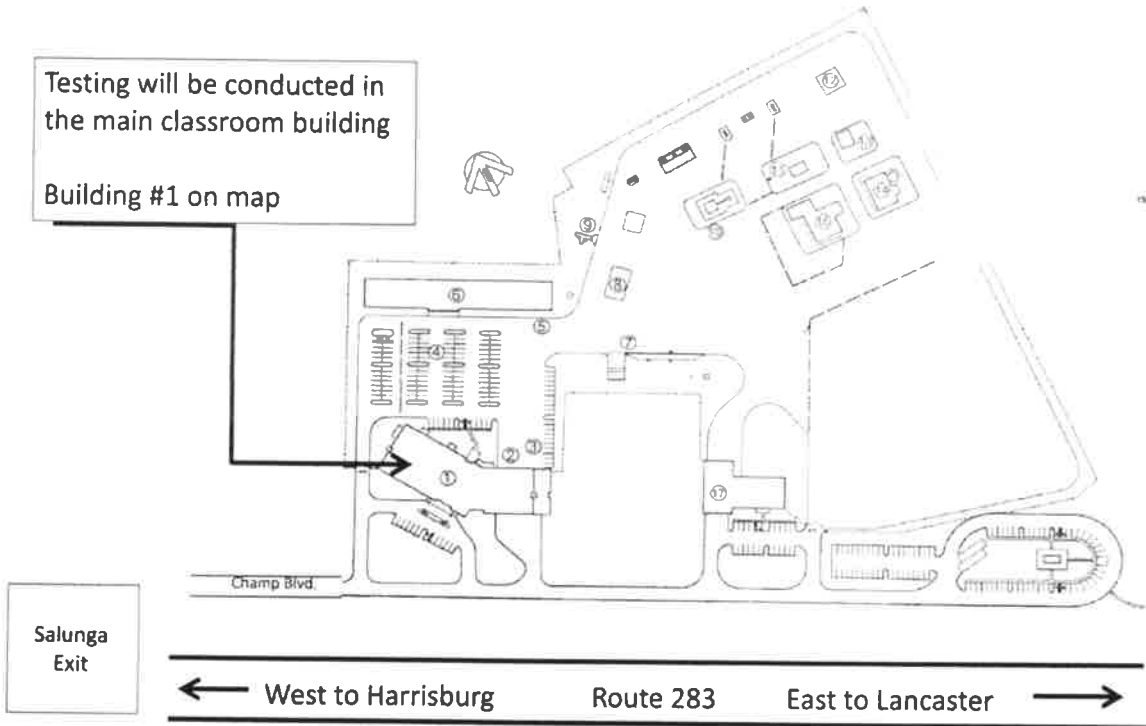

### Who may be Eligible for Veterans' Preference

To be eligible for veterans' preference, an applicant must first meet the definition of "Veteran," as provided in the [Veterans' Preference Act, 51 Pa.C.S § 7101.1-7111](#). Applicants in any of the following categories are considered to be Veterans for the purposes of veterans' preference:

1. An individual who has completed service in the armed forces of the United States, including a reserve component or National Guard, **has completed their initial contractual military service obligation**, and their last discharge or release was under conditions other than "dishonorable".
2. An individual in the armed forces of the United States, including a reserve component or National Guard, who has served during a period of war or armed conflict (as determined by the United States Department of Defense), has completed a tour of active duty for purposes other than training, was released from that period of active duty under conditions other than "dishonorable" and continues to serve in a reserve component or National Guard.
3. An individual in a reserve component or National Guard, who has completed an initial contractual military service obligation and continues to serve.
4. An active-duty member of the armed forces of the United States who is completing a tour of active duty that is three (3) years or more and is within ninety (90) days of an approved discharge or release, as evidenced by documentation of the projected discharge or release from active duty under conditions other than "dishonorable."

The hiring preference afforded to Veterans under the Veterans' Preference Act is also extended to Surviving Spouses of a deceased Veteran and Spouses of a Disabled Veteran. The deceased or disabled service member must meet the definition of "Veteran," as provided in the Veterans' Preference Act, 51 Pa.C.S § 7101.1-7111. A disability must be classified by the U.S. Department of Veterans Affairs, Veterans Benefits Administration as a permanent total disability.
