By acceptance and execution of this permit, the permittee agrees as follows: The permittee shall assume responsibility for all damages caused persons or property, and further agree to abide by the rules and regulations of Manheim Township as given below. The permittee shall provide all barricades, flashers, flares, danger signs, etc. necessary for the proper protection of the public and the regulation of traffic during the time the tree is under removal. The permittee shall provide proof of liability insurance satisfactory to the Township. Please complete this form and email it to publicworkspemits@manheimtownship.org.

Regulations Regarding Care of Trees:

1. All cuts 2 inches or over shall be painted with a proper tree paint.
2. A street and pavement clearance of 12 to 14 feet shall be maintained on larger trees.
3. More mature trees have been hurt by severe pruning than have been helped. The worst treatment a tree can receive is to cut off the top, "healing down", so often practiced is under the guise of tree pruning, either from a false notion of forming a top or for the passage of wires.
4. Any limb to be removed should be cut off flush at parent branch. No stubs or protuberances should be left to prevent decay and slow healing.
5. This permit is void one (1) year after date of approval.
