Indemnitors hereby agree to indemnify and hold harmless Township, its officers, directors, employees, agents, representatives, successors, affiliated entities, administrators, assigns and insurers, from and against any and all manner of claims, actions, causes of action, suits, demands, debts, dues, accounts, bonds, covenants, contracts, agreements, judgments, costs and expenses (including reasonable attorneys' fees), whatsoever in law or equity, arising out of the manufacture, transportation, possession, installation, firing, fallout, detonation, combustion, deflagration or disassembly of any pyrotechnic equipment or device and/or the supervision, performance, conduct, display and presentation of display fireworks on the Property identified in the related Fire Permit Application.

2. The applicant of the Fire Permit Application has provided copies of the required insurance certificates to the Township naming the Township as an additional insured. Copies of the insurance certificates are attached to this Agreement.

3. This Agreement constitutes the entire understanding between the parties with respect to the subject matter hereof, and shall not be amended except in writing signed by both parties.
